Pippin Hikes processes your personal data for the following purposes:

Making a booking based on filling in the booking details, we receive your e-mail address, home address, telephone number and an emergency telephone number for any calamities. We process this data in an Excel and Word file. This information is provided to Certo Escrow for payment for European customers. We store this data for a maximum of 7 years because this is necessary for tax purposes. We also do this so that we know how often you book with us and which trips, so that we can keep the contact personal.

Subscribe to a newsletter for subscribing you provide us with your e-mail address. You can unsubscribe from the newsletter at any time, so that we no longer have your e-mail address. This can be done at the bottom of every newsletter. Our newsletter is handled by Wix, with whom we have concluded a processing agreement. Personal data that we process with our website PippinHikes.nl processes your personal data because you use our services and/or because you provide it to us yourself.

Cookies, or similar techniques;

Pippin Hikes only uses technical and functional cookies. In addition, we use analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously saved via the settings of your browser.

view, modify or delete data;

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Pippin Hikes and you have the right to data portability. This means that you can submit a request to us to send the personal data we hold about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to info@PippinHikes.nl.



To ensure that the request for inspection has been made by you, we ask you to enclose a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks. The copy of your proof of identity will be deleted after the desired change has been processed.

How we secure personal data;

Pippin Hikes takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. If you have the impression that your data is not properly secured or there are indications of abuse, please contact info@PippinHikes.nl

PippinHikes does not sell your information to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Pippin Hikes remains responsible for these processing operations.
